2. Booth Space:

- a. Booth space approximately
 - i. 10ft x 10ft \$40.00 (NO booth sharing allowed)
 - ii. Smaller booth – size to be determined upon setup \$25.00 (no bigger than 6ft x 6ft).
- b. **EXHIBITOR** agrees to lease
 - i. _____ 10 x 10 booth for \$40.00 = \$ _____
 - ii. _____ smaller booth for \$25.00 = \$ _____
 - iii. Only one **EXHIBITOR** per lease space
 - iv. Each **EXHIBITOR** will get two free admissions per each vendor
 - v. All other people helping (and public) will pay \$5.00 general and parking admission
 - vi. CONTRACT DUE BY JANUARY 30, 2026

Event: Subjects to the terms and conditions of this Agreement, the ORGANIZER leases to the EXHIBITOR the booth space described in **(2) Booth Space** of this Agreement for the 2026 Tack Swap at Kirkwood to be held **Saturday, February 7, 2026.**

- All lease spaces must be on contract by January 30, 2026
- **EXHIBITOR** assumes all other costs, such as additional lighting, signage, carpeting, tables, chairs, etc.
- The leased booth space shall be used exclusively by **EXHIBITOR** and **CANNOT** be leased to another **EXHIBITOR**.

3. Booth Selections: Subject to Availability

- a. Handicap will be placed **FIRST** to allow easier access
- b. All vendors will be placed based on suitability by ORGANIZER

4. Failure to Occupy Leased Booth: **EXHIBITOR** agrees to occupy the leased booth for the FULL duration of the EVENT.

- a. If **EXHIBITOR** does **NOT** occupy the leased booths for the EVENT, they are **STILL** responsible for the FULL rental fee. Must be setup by 7 a.m. Saturday or booth will be resold
- b. A \$20.00 **EARLY** departure fee will be charged

5. Notice of Cancellation: If EXHIBITOR desires to cancel this agreement, the EXHIBITOR shall notify ORGANIZER of his/her desire to do so 15 days **PRIOR** to the EVENT. There are **NO REFUNDS** for ANY reason.

6. Set Up and Tear Downs:

- a. Friday, February 6, 2026 EXHIBITOR set up 1:00pm-12:00am
 - b. Saturday, February 7, 2026 Doors open at 5:00 am for additional set up time
 - c. Saturday, February 7, 2026 EXHIBITOR set up must be complete NO LATER THAN 7:00am. If not, booth area will be resold.
 - d. Booth(s) tear down NOT before 4:00pm Saturday, February 2026 or EXHIBITOR will be charged a \$20.00 EARLY departure fee
 - e. EXHIBITOR is responsible for cleanup of space (s) leased no trash left behind allowed.
- 7. ALL EXHIBITORS are responsible for their own sales taxes**
- 8. Returned Check Fee:** \$40.00 charged on any/all returned checks
- 9. Food & Drink Sales:** PROHIBITED by any EXHIBITOR
- a. IA Equestrian Center Concessions stand will be open the day of the event.
- 10. Due to past complaints NO PETS (dogs) ALLOWED-SORRY...**
- 11. NO vendor parking in front lot**
- 12. NO SMOKING Policy is ENFORCED by the IA Equestrian Center & Kirkwood Community College which includes smokeless and smoking tobacco**
- 13. ORGANIZER has the right to refuse any vendor without reason**
- 14. PLEASE NOTE IF YOU'RE A RETURNING VENDOR**
- a. ORGANIZER Kathy Peterson-Herbst, the IA Equestrian Center & Kirkwood Community College, and or leaser of facility are not held responsible for theft, accidents, injuries, or loss of any property.
